Permit Number 0183

In compliance with the provisions of Chapter 23 of the Ops City Code, North Carolina General Statute 143-215.1, 40 CFR 403, 40 CFR 439 Subpart C, and other lawful standards and regulations promulgated and adopted by the North Carolina Environmental Management Commission and the City of Ops, the following industry,

Fleming Laboratories, Incorporated

Hereafter referred to by name or as the Permittee, is hereby authorized to:

1. Continue operation of the existing pretreatment facility, consisting of **1200 gallon neutralization tank, filters, and carbon canisters**, located at **2205 through 2215 Thrift Road Ops, North Carolina 28208**; and
2. After receiving authorization to construct from the Control Authority, construct and operate additional pretreatment units as needed to meet final effluent limitations, monitoring requirements and all other conditions set forth in Parts I, II, and III hereof; and
3. Discharge wastewater from the pretreatment facility into the City of Ops, Irwin Creek Wastewater Treatment Plant NPDES Number NC0024945, in accordance with effluent limitations, monitoring requirements and all other conditions set forth in Parts I, II and III hereof.

This permit shall become effective **September 30, 2004**

This permit and the authorization to discharge shall expire at midnight on **September 15, 2009**
